### 3) Receive Long-Term Project Outlook or Allen Community Development Corporation.

Dan Bowman spoke regarding the different types of potential projects to come before the Allen Community Development Corporation (ACDC) in the future. Currently several projects along Hwy 121 corridor such as Allen Gateway, The Avenue, The Farm, The Hub, and Monarch City. Approximately 900 acres to develop with some connection to the parks and trail system. Looking for ACDC participation in projects that will engage citizenry to the area as a destination entertainment area, funds to be used for specific investments in tangible assets, activating green spaces with mixed-use developments and making the Hwy 121 corridor unique centers of recreational activity. Dan mentioned that projects foreseen are market driven, require vetting and negotiation and are highly competitive and confidential. Sometimes we may only have a 3-6-month outlook as to what the market brings forth. Most often projects are part of a larger project involving the City and Allen Economic Development Corporation.


# City of Allen, Texas March 2021 - Revenue Report

# **Sales Tax:**

Below is the monthly summary of sales tax receipts for the March 2021 reporting period, which reflects sales that took place in the month of January 2021. January 2021 receipts were \$3,392,762, which represents a increase of 6.12% from January 2020 receipts of \$3,197,094. Collections year-to-date equal \$15,902,784 or 3.98% more than the same period last year. At 12.46%, McKinney had the highest increase for the current month as compared to the prior year, while Dallas had the weakest showing at -9.34%. Receipts for Collin County were up by 4.99% over this time last year and the State of Texas' Collections were 1.50% higher.
