**BACKGROUND** 

Section 7.08 of the Allen City Charter states:

"Returns of all municipal elections, both general and special, shall be made in accordance with the Texas Election Code, at which time the council shall canvass the votes, declare the results of such election, with notification of election to the candidate elected."

and Section 67.003 of the Texas Election Code states:

"Each local canvassing authority shall convene to conduct the local canvass at the time set by the canvassing authority's presiding officer not earlier than the eighth day or later than the 11th day after Election Day."

The Early Voting Ballot Board reconvened to count returned military overseas ballots (FPCA - Federal Post Card Application), mail in ballots and provisional ballots. There was one provisional ballot cast and counted and five mail ballots received by the deadline of 5 p.m. on Monday following the election and counted in the City of Allen General Runoff Election.

# **STAFF RECOMMENDATION**

Staff recommends that Council conduct the canvass and considers the proposed resolution declaring the results of the June 16, 2018, General Runoff Election in accordance with State Law and the Allen City Charter.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ALLEN, COLLIN COUNTY, TEXAS, DECLARING THE RESULTS OF THE RUNOFF ELECTION OF THE CITY OF ALLEN HELD JUNE 16, 2018, FOR THE PURPOSE OF ELECTING THE CITY COUNCILMEMBER FOR PLACE NO. 3; AND PROVIDING AN EFFECTIVE DATE.

**SECTION 1.** Said election was duly called, that notice of said election was given in accordance with law, and that said election was held in accordance with law, and that Lauren Doherty was duly elected Councilmember for Place No. 3. Above named party is hereby declared duly elected Councilmember for Place No. 3, subject to the taking of the oath-of-office as provided by the laws of the State of Texas.
